Memorandum of Understanding

This Memorandum of Understanding is made on this 13th day of September month of the year 2024

#### BY AND BETWEEN

**Dabake Trust**, an institution registered under the Bombay Trust Act 1950 and having its Office at Pune, represented through its Trustees; Mr. Arvind Paranjape, age: - 67 adult, Occ-Consultant (hereinafter referred to as "**Donor/said Trust**", which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its administrators and permitted assigns)

#### **AND**

MES's Abasaheb Garware College, a premier autonomous college of Maharashtra Education Society, located at Karve Road, Pune 411004, represented through its Principal Dr. Vilas Ramchandra Ugale, age: - 51 adult, Occ- Service (hereinafter called "MES AGC/said College" which expression shall unless it be repugnant to the context or meaning thereof be deemed to mean and include its administrators and permitted assigns)

#### WHEREAS

- 1. "MES's Abasaheb Garware College" is an autonomous NAAC Re-accredited 'A' Grade college offering courses in the streams of Arts and Science in the city of Pune and has been conferred the "Best College" Award by Savitribai Phule Pune University.
- 2. **MES AGC** also runs **post graduate courses** in the field of **Material Sciences** (Physics, Chemistry and Electronic Science) and **Life Sciences** (Biotechnology, Biodiversity and Microbiology).
- 3. The purpose of this MOU is that the said Trust is desirous to give donation/grant to deserving post graduate student(s) of Material Sciences and to deserving post graduate student(s) of Biological Sciences of MES AGC and MES AGC is ready to accept the grant/donation from the said Trust.

NOW THEREFORE, IT IS HEREBY AGREED BETWEEN THE PARTIES AS FOLLOWS:

1. Terms of MOU- This MOU is effective on the date mentioned herein above and shall remain in full force and effect for **not longer than 3 years** from the date of its execution. This MOU may be terminated after reviewing the usefulness of this grant by both the parties with mutual consent.

2. Purpose of MOU- The said Trust has offered to grant to deserving post graduate student(s) of Material Sciences and to deserving post graduate student(s) of Life/Bio Sciences of MES AGC. The Principal of MES AGC or his representative will ask for applications from the students of aforementioned post graduate departments who wish to avail this grant.

#### 3. Roles and Responsibilities of MES AGC-

- a) In order to disburse the amount of grant/funds, MES AGC will appoint a "screening committee" and conduct screening procedure for selecting the deserving candidates from the above-referred departments. This screening committee shall consist of representative(s) of 'Dabake Trust', representative(s) of MES AGC and subject experts.
- b) It shall be the responsibility of MES AGC to disburse the amount of grant to the candidates selected by the screening committee.
- c) If in case, the screening committee is unable to decide on a suitable research project entitled to receive grant, then under these circumstances, the grant given by the said Trust shall be utilised by MES AGC for the purpose of development of post-graduate departments or for any expenses other than consumables.
- d) The right of distribution of the funds and monitoring of the expenditure shall be the responsibility of the Principal, AGC or his authorized representatives.

#### 4. Roles and Responsibilities of Dabake Trust-

- a) Dabake Trust shall provide grant of Rs.50,000/- (Rupees fifty thousand only) and Rs. 10,000/- (Rupees ten thousand only for administrative expenses, such as honorarium to examiners) for a period of one year to conduct research projects in the aforementioned post graduate departments of MES AGC.
- b) Dabake Trust promises to keep this support for 3 years from the date of execution of this MOU and after the review of both the parties.
- c) In case of deserving projects and as per the recommendation of the screening committee, Dabake Trust may increase the amount of grant and period of the research.
- d) Dabake Trust shall disburse the amount of grant to MES AGC after the report/result of the screening committee.

- e) The trustees of Dabake Trust feel that, such a selected research project, after its completion should be sent for competition on various platforms like; University level, State level and even National level. MES AGC should encourage such projects to be showcased on various platforms.
- f) The trustees of Dabake Trust feel that post graduate students of science department should be encouraged to take up research projects which are directly contributing to the betterment of the environment, development of user-friendly technology making the life easier of human kind in our country with low cost and innovative solutions.
- g) Mr. Vasudeo Kshirsagar will work as a Coordinator for this activity on behalf of Dabake Trust.

#### 5. General Clauses-

- a) This MOU shall not be construed as creating any contractual relationship of that as a Principal and agent etc., between the parties hereof except that of the Donor and MES AGC as Donee.
- b) This MOU constitutes the entire understanding of the Parties with respect to the subject matter contained herein and supersedes all prior discussions and understanding between the Parties concerning such subject matter, whether written or oral.
- c) Amendment- Either party may request changes to this MOU. Any changes, modifications, revisions or amendments to this MOU which are mutually agreed upon by and between the parties to this MOU shall be incorporated by written instrument and effective when executed and signed by all parties to this MOU.
- d) There will be a review at the end of the 3-year period after which decision will be taken with respect to continuation of the grant with mutual consent of the parties.
- e) If any dispute arises between the parties to this MOU regarding the construction, interpretation and enforcement of the rights and responsibilities of the parties to this MOU or failure, negligence of the parties to perform any term or condition of this MOU or to bring an action for breach of this MOU, then the laws of the land shall be applicable and the courts at Pune shall have jurisdiction to try the matter(s) connected therewith.

f) Severability- Should any portion of this MOU be judicially determined to be illegal or unenforceable the remainder of the MOU shall continue in full force and effect and either party may renegotiate the terms affected by the severance.

#### Letter of Understanding (LoU)

This Letter of Understanding (LoU) is entered into on this date 5<sup>th</sup> August 2024 at Hyderabad.

#### BETWEEN

Research and Extension Association for Conservation Horticulture and Agroforestry (REACHA), having its Registered Office at 177-178, 2nd Floor, Triveni Apartments, Jhilmil Colony, Delhi, India 110095, (hereinafter referred to as REACHA or the First Party) which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successor, administrators, legal representatives and executors assigns of the First Part

#### AND

MES Abasaheb Garware College, Karve Rd, Pune, Maharashtra 411004, India(hereinafter referred to as MES Abasaheb Garware College or the Second Party) which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successor, administrators, legal representatives and executors assigns of the Second Part

**REACHA** and Loyola Academy Degree and PG Collegeshall individually be referred to as "Party" and collectively as "Parties".

#### Recitals

- I. Whereas, IBM SkillsBuild represented by its country partner for India REACHA, is a skill building & learning digital platform where users can achieve industry relevant skills, get IBM certificates and certified badges & seek employment opportunities. This would be applicable based on assessment by REACHA.
- II. Whereas MES Abasaheb Garware College (Second Party) is keen to introduce IBM SkillsBuild for students of the Second Party.
- III. Whereas the First Party wants to collaborate with specialized agencies/institutions to achieve industry relevant skills required under the IBM SkillsBuild Project.
- IV. Whereas the Second Party have shown interest in providing desired skills by the First Party for implementation of the IBM SkillsBuild Project.

V. Whereas, at the suggestion of Second Party, the First Party has agreed to collaborate with Second Party for availing their expertise for SkillsBuild Project for various activities as listed hereinafter.

Therefore, the Parties agree to collaborate for the Project in respect of activities and on terms and conditions given in succeeding para in this Letter of Understanding (LoU). It is reiterated that this LoU is only an expression of interest to collaborate for the Project and neither Party shall have any rights or obligations with respect to each other besides the activities listed below in this LoU.

The Project aims to inculcate requisite knowledge, experience, and skills amongst students. As per UGC Guidelines of December 2022, for Fostering Social Responsibility & Community Engagement in Higher Education Institutions (HEIs) in India, Institutions should prioritize social responsibility and community engagement in their mission and operations (refer to Guidelines for Fostering Social Responsibility and Community Engagement in Higher Education Institutions in India 2.0). It calls for integration of community engagement into graduation requirements, assessments, and performance evaluations while offering suggestions for different forms of community engagement. The Guidelines further suggest forms of community engagement which may include linking learning with community service, linking research with community knowledge and knowledge sharing, and knowledge mobilization. Furthermore, as per the Guidelines for performance assessments of teachers, administrators in HEIs should include the view of their involvement and contributions to community engagement in teaching and research. Criteria of and weightage to community engagement by teachers and researchers should be explicitly included in assessments for recruitment, regularization, and promotion.

One of the major objectives of the Project offered by IBM and implemented by REACHA is to facilitate colleges in achieving all of the above-desired goals.

#### Objectives

- 1. The objective of this LoU is to mutually complement Parties' energies, outreach, and efforts to curate opportunities of collaboration, sharing of knowledge resources and jointly work on building capacities of the users through the IBM SkillsBuild Platform.
- 2. Parties will enable IBM SkillsBuild for 1000 students from MES Abasaheb Garware College of Arts and Science through facilitation and guidance with prime focus in the state where the Second Party is located.
- 3. The identified students would be encouraged to take up and complete courses on IBM SkillsBuild platform by the Parties. The Second Party must ensure a minimum of 80% attendance as active learning (8-10 hours of dedicated learning and course completion under Project Based Learning as defined by IBM SkillsBuild) per month of onboarded learners.
- 4. Relevant Faculty Development initiatives may also be taken up for the benefit of the staff of the Second Party by the First Party.

#### Duration

This LoU is valid from 5<sup>th</sup> August, 2024, up to three years from the date of signing subject to active IBM – REACHA (First Party) Memorandum of Understanding (MoU) / Agreement during that period, on a year-on-year basis, under which First Party is able to provide these benefits of 21st century skills for youth / students of Second Party.

#### **Operational Aspects**

Parties will work closely with their teams to leverage their student/learner base and other important stakeholders to build industry relevant skillsets & enhance employability prospects of students/ learners by providing market-linked skills. First Party will facilitate the on-boarding of learners (students) on the platform with assistance and in collaboration with Second Party and encourage students to leverage the platform for better learning opportunities.

The focus would be to bring in 21st century skills like - Artificial Intelligence, Cybersecurity, Job Readiness Skills, Digital Marketing, Effective Communication, etc. as offered by IBM SkillsBuild, to the students, which can help them to learn skills that are needed in the market, and can help them to get ready to access job and entrepreneurship opportunities in the market.

The Second Party must ensure a minimum of 80% attendance as active learning (8-10 hours of dedicated learning and course completion under Project Based Learning (PBL) as defined by IBM SkillsBuild) on IBM SkillsBuild platform per user per month through participation in innovation camps and other learning activities.

The Second Party shall provide the required facilitation for access to employability for eligible and meritorious students as part of this IBM SkillsBuild Project.

The Second Party shall nominate a Single Point of Contact (SPOC)/ Volunteer faculty to act as facilitator between students and REACHA Digital Success Manager/team. The SPOC can be provided with "Letter of Appreciation", from the First Party based on performance during the Project.

The Second Party must provide/facilitate the necessary infrastructure (High-Speed Internet Connectivity, computers/smartphones, projector/ screen, Mic and sound system, classroom/ auditorium) during sessions conducted by First Party.

The Second Party shall provide Student Volunteers for the coordination and smooth execution of the Project. These Student Volunteers can be provided with "Letter of Appreciation" from the First Party based on their performance during the Project.

The First Party may provide the Second Party with the opportunity to explore additional permitted offerings deemed relevant to enrich the learning experience and skill building opportunities for the Second Party subject to the terms and conditions of the IBM Memorandum of Understanding (MoU)/Agreement

with the First Party on a year-on-year basis and compliance to applicable IBM policies, rules, and regulations.

In order to maintain the desired level of social media outreach, each Party promises to follow the guidelines for social media amplification sent as a part of the communication package as per IBM norms/approved by IBM on case-to-case basis. With respect to the social media outreach, each Party will also appoint an appropriate person(s) to represent the organization.

#### Termination and Extension of LoU

In the event of non-compliance or breach of terms by any one of the Parties of the obligations binding upon it, the other Party may terminate the LoU with immediate effect by a simple notice in writing without assigning any reason, whatsoever.

This LoU can be extended further as per the mutual consent between the parties in writing.

### Financial Aspects and Conflict of Interest

This LoU has no financial implications for the Parties with respect to each other or to any other party. Parties shall ensure there is no conflict of interest during the delivery of the Project.

In the event of any dispute, controversy, or differences arising out of or relating to this LoU, the Parties agree to resolve the matter amicably through mutual discussion in the spirit of partnership.

The First Party shall be represented by Shri Nikhil Pant, Chairman & Chief Executive Officer, on behalf of REACHA. The Second Party shall be represented by Dr.Manisha Bharambe of MES Abasaheb Garwarc College. They or their representative will sign communications and take decisions in respect of matters covered under the LoU and it will be binding to their respective organizations.

The terms and provisions in this LoU also apply to any subsequent Addendum to this LoU.

b) not use the Confidential Information disclosed or made available by FCI for any purpose whatsoever, except (and only) to the extent necessary in connection with the Relationship for which, the Confidential Information was disclosed.

- c) disclose the Confidential Information disclosed or made available to it by FCI only to those of its directors, officers, employees and agents (including the Recipient's professional advisers who have by their profession a duty of confidence or who agree in writing to hold the Confidential Information in confidence on substantially similar terms to the obligations of confidence under this Agreement) (collectively, the "Personnel") having a manifest need to know such Confidential Information and shall take all reasonable precautions to ensure that its Personnel comply with this section 2.
- d) restrict disclosure of the Confidential Information strictly to those persons with a "need to know" basis. The Recipient shall ensure that such persons are made aware of the restrictions contained herein regarding use of Confidential Information and are bound by confidentiality agreement with the Recipient in terms similar to those in this Agreement;
- e) not copy, reproduce or modify any Confidential Information without the prior written consent of FCI.
- f) comply with all applicable laws while dealing with the Confidential Information including but not limited to all applicable regulations of the U.S. Department of Commerce Office of Export Administration and/or such other agencies and Data Protection Law.
- g) ensure compliance of all information security requirements of FCI applicable to its engagement if working on FCI' premises as well as onsite premises;
- h) not use the Confidential Information of FCI, in whole or in part, to compete with FCI or otherwise in detriment to the interests of FCI
- i) Not, directly or indirectly, do anything, including reverse engineering, that is intended to reveal the source code of any software included in the Confidential Information as disclosed by FCI.

#### 3) EXCEPTIONS TO OBLIGATIONS OF CONFIDENTIALITY

The Recipient's obligations to maintain the confidentiality shall not apply to any Confidential Information that as shown by appropriate evidence: (i) was already in its possession at the time of disclosure or when made available and without restriction as to confidentiality, (ii) at the time of disclosure or when made available is already generally available to the public or after disclosure becomes generally available to the public through no breach of agreement or other wrongful act by the Recipient, (iii) has been received from a third party without restriction on disclosure and without breach of agreement or other wrongful act, (iv) is independently developed by the Recipient without benefit or use of the Confidential Information, (v) is required to be disclosed by law, regulation or order of a court of competent jurisdiction or other governmental authority, to the extent of such required disclosure, provided that the Recipient shall furnish prompt written notice of such required disclosure and reasonably cooperate with the FCI, at FCI's cost and expense, in its lawful attempts to seek a protective order or other appropriate protection of its Confidential Information, or (vi) is approved for release upon the prior written permission of FCI. The burden of proving that information is not Confidential Information shall be on the Recipient.

#### 4) NO FURTHER OBLIGATIONS

The furnishing of the Confidential Information hereunder shall not obligate either party to enter into any further agreement or negotiation with the other for any proposed business transaction or to refrain either of the parties from entering into an agreement with any other party. Until a written definitive agreement has been executed and delivered, neither party will have any liability to the other party with respect to any proposed business or vendor relationship, whether by virtue of this Agreement or by any other written or oral expression with respect to the discussions between the parties.

#### 5) REMEDIES

Recipient acknowledges that FCI will have no adequate remedy at law if it violates any of the provisions of this Agreement. Accordingly, FCI shall have the right, in addition to any other rights and

remedies it may have, at law, in equity or otherwise, to seek in any court of competent jurisdiction injunctive relief to restrain any breach or threatened breach hereof or otherwise to specifically enforce any of the provisions of this Agreement.

#### 6) RETENTION OF RIGHTS

All materials and Confidential Information furnished under this agreement shall remain the sole property of FCI (or the third party from which FCI obtained such materials or Confidential Information) and no license or other rights to any materials or Confidential Information of FCI (or the third party from which FCI obtained such materials or Confidential Information) or any trademark, trade-secret, patent, copyright or other proprietary right owned or controlled by it are acquired or obtained by the Recipient (whether by estoppel, implication or otherwise).
